Although the East Lake Farmers Market (“ELFM”) will make its best effort to accommodate your preferences, the farmers’ CSA shares are reserved on a first-come, first-served basis. If ELFM cannot accommodate any of your three preferences, ELFM will contact you to discuss alternative farms. If you decide not to participate with the alternative farms, ELFM will refund your down payment in full. If ELFM can accommodate *any one* of your three preferences, the down payment cannot be refunded. Therefore, please **do not list any farm in whose CSA you are not interested in participating.**

**Down Payment**

\$200 per full share; \$100 per half share. The entirety of the down payment is applied toward the total cost of your CSA share(s). Down payment may be paid in person by cash or check or via Mail to:

Down payment tentatively reserves a spot with your highest available farmer. This reservation is contingent upon payment of your balance by the deadline.

**Returning Completed Applications**

The completed application form and down payment are due by **1:00 p.m. on Saturday, July 23, 2011.** ELFM’s Market Manager, Lou Linzie, must *receive* the application form and down payment *by this time.* Applications may be submitted in person (to the ELF Market Manager), via U.S. mail (East Lake Farmers Market c/o Lou Linzie 1729 DonnaLee Ave. Atlanta, GA 30317), or via e-mail (info@elfmarket.org).

**Note: applications are not deemed accepted until the down payment has also been received.**

**Balance Due**

Once ELFM determines which farm preference you have received, ELFM will notify you via e-mail of the selection and the balance that is due. For example, if you signed up for one full share at \$30 per week, the total cost is \$330. Because the down payment for a full share was \$200, the balance due would be \$130. **YOUR BALANCE IS DUE TO ELFM’S MARKET MANAGER BY 1:00 P.M. JULY 30, 2011. FAILURE TO PAY YOUR BALANCE FORFEITS YOUR DOWN PAYMENT AND YOUR ABILITY TO PARTICIPATE IN THAT SESSION’S CSA.**

**Disclaimer**

The purchase of a CSA share is an investment in the farm that you choose. Although it is in the farmers' best interest to ensure their shares are available on a weekly basis, there is a chance that events beyond their control (including but not limited to drought, flood, fire, or other acts of God) may make production or delivery impossible. If a farm loses its crop through not fault of its own, you may receive no produce for the remainder of the session. Because **this is an investment** in the farm, **no refunds will be given**. Neither ELFM nor the individual farm is liable for any funds lost through this investment.

**Share Distribution**

CSA members must pick up their share(s) between 9:00 a.m. and 1:00 p.m. each Saturday during the session for which they have registered. If members are unable to pick up their share(s) on any given week, they are responsible for making arrangements for someone to attend the pick up. **Shares not claimed by 1:00 p.m. will be donated.**
